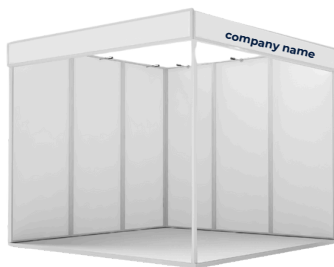

GENERAL CONDITIONS

1. Exhibitors and Products

1.1. Exhibitors admitted include manufacturers, importers, exporters, representatives, and traders presenting services and products that fall within the theme of the event they are participating in. Exhibitors are responsible for the accuracy of the information presented with the purpose of selling a creation (image, description, materials used, dimensions, price) and are obligated to comply with the regulations for the protection of industrial and intellectual property valid in Romania regarding the products and services they exhibit as exhibitors.

1.2. Obtaining the required authorizations by law for the products/goods and services presented is the sole responsibility of the exhibitor. The exhibitor is obligated to provide proof of holding the required authorizations by law at the date of signing the adherence, as well as upon request by the control authorities. Selling or exhibiting products/services is permitted in compliance with the legislation in force in Romania. The exhibitor is responsible for the accuracy of the information presented and the actions taken, as well as for compliance with the legislation. Illegal or specially regulated articles/goods are not permitted.

1.3. Participation in fairs and exhibitions organized by CCINA Constanta is based on the General, Technical, and Participation Conditions, which are an integral part of the contract and can be consulted on www.ccina.ro.

2. Registration and Participation

2.1. The exhibitor submits the completed Adherence-Contract until the latest date mentioned. After this date, adherences are accepted within the limit of available space, and the Organizer will send the proposal for the location together with the proforma invoice. Depending on the technical possibilities, the allocated area, as well as the configuration of the exhibition space, may differ from those requested, or participation may be refused by the organizer. Subsequently, the organizer will communicate in writing to the exhibitor the allocated space and the corresponding proforma invoice.

2.2. The allocation of spaces will be made according to the registration date, area, loyalty, technical requirements (handling, electrical connections, compressed air, water supply), and requests for free sides.

2.3. If the Organizer cannot offer the requested space, alternative options will be provided. The surface allocated by mutual agreement may differ from the one requested, or participation may be refused by the organizer if deemed necessary and useful for the successful conduct of the event.

2.4. Exhibitors are obliged to respect the allocated and contracted space without exceeding it.

2.5. The exhibitor's confirmation of the stand project, to be built by CCINA Constanta, must be made within a maximum of 5 days from the date of sending the project.

2.6. The exhibitor is obliged to take over, by minutes, the rented space and goods and deliver them in good condition, being considered to have received them in good condition at the expiration of the rental period. In the event that, upon delivery of the space and goods, the Organizer finds damages and/or shortages, they will be mentioned in the minutes signed by both parties. The beneficiary undertakes to pay the value of these, based on the invoice issued by the Organizer.

2.7. Access of exhibitors to the contracted space is permitted within the established interval, only if they have fully paid their obligations to the Organizer. Exhibitors undertake not to affect or block in any way through their activity the common areas within the Pavilion Expositiional Constanta.

3. Withdrawal

3.1. In case, after the conclusion of the contract and payment, the exhibitor withdraws from participation with:

- 60-45 days before the opening of the event, 30% of the amounts paid will be retained;
- 44-30 days before the opening of the event, 50% of the amounts paid will be retained;
- 29-15 days before the opening of the event, 70% of the amounts paid will be retained;
- less than 15 days before the opening of the event, 100% of the amounts paid will be retained.

If the exhibitor withdraws under the above-mentioned conditions, the amounts already paid by the exhibitor will be retained to compensate for the material damage caused to the Organizer.

4. Payment Terms and Methods

4.1. For all types of stands, payment will be made by bank transfer, before taking over the stand (in advance), to the accounts mentioned on the proforma invoices sent by the Organizer. The exhibitor's takeover of the stand will be done only after presenting the documents confirming the full payment of the invoices issued by the Organizer.

4.2. For the construction of a customized stand, the Organizer is not involved in the necessary logistics, this action being entirely the exhibitor's obligation. Bank charges are borne by the exhibitor.

5. Schedule

5.1. Exhibitor access program:

- During the assembly/arrangement period of the stands, access of exhibitor personnel will be allowed daily between 8:00 - 20:00, for arrangement with third-party or own companies. For arrangement with CCINA Constanta, access will be allowed between 8:00-20:00. Removal of exhibits from stands/dismantling can be done from the day following the end of the exhibition, between 9:00-20:00.
- During the exhibition period, access of exhibitor personnel will be allowed daily between 8:00-19:00.
- Exhibitors are obliged to strictly adhere to the exhibition schedule and not to leave the rented stand until the end of the event.
- Stands not taken over by 18:00, on the last day reserved for assembly, will be allocated to other companies; failure to take them over within the specified period by the exhibitor is equivalent to canceling the participation.

- Each exhibitor will benefit from access badges for the entire duration of the event.
- The name of the exhibiting company will be written on all access badges. Badges are not transferable. The Organizer reserves the right to retain any badge that is not used properly.
- Exhibitors' vehicles do not have access inside the Pavilion Expositiional Constanta during the exhibition period. They will be parked in specially designated spaces.
- During the assembly/dismantling period, only exhibitors' vehicles with goods have access to the pavilion area.

5.2. Visitor access program:
- Daily, between 10:00-18:00.

6. Advertising within the Exhibition Center

6.1. Exhibition and distribution of leaflets and promotional materials are free within the rented area of the exhibitor (own stand).

6.2. Advertising is limited to promoting the exhibitor's products and will not violate legal provisions, will not be political or ideological in nature. Comparative advertising is not allowed. The Organizer has the right to remove without the exhibitor's consent inscriptions, advertisements, and other forms of advertising made inside and outside their own stand if they consider them not in accordance with Romanian legislation, participation conditions, or if they disturb other exhibitors.

6.3. The Organizer reserves the right to prohibit the display or distribution of advertising materials that could give rise to offenses against other exhibitors and will take measures to remove existing stocks of materials during the event.

6.4. Advertising through optical, mobile, and acoustic media (maximum 55 dB) is allowed only if it does not disturb neighboring exhibitors and does not cover the sound inside the pavilions (radio announcements, etc.). In case of violation of these provisions, the Organizer reserves the right to intervene and request the cessation of the advertising message, and the exhibitor undertakes to compensate the Organizer for any damage caused as a result of non-compliance with legal provisions regarding noise limit values and environmental protection.

6.5. Exhibitors must comply with the provisions regarding copyright, in accordance with the provisions of Law no. 8/1996 on copyright and related rights.

7. Security/Responsibility

7.1. The Organizer ensures general security outside the pavilion outside daily hours, without being held responsible for the security of the exhibited products. It is recommended to insure goods or personal insurance. This can be done through specialized companies, paying the required fees.

7.2. In case any of the goods are declared missing, the exhibitor is obliged to immediately notify the Police Section.

7.3. The exhibitor is responsible for the security of the goods during the daily schedule, in accordance with art. 51.

7.4. Exhibitors will comply with legal provisions regarding fire prevention, health, and safety at work, and those related to damage caused on the territory of Pavilion Expositiional Constanta, by visitors or exhibitors, in accordance with the Romanian Civil Code and the General, Technical, and Participation Conditions.

7.5. Smoking in stands and pavilions is strictly prohibited and is only possible in specially designated outdoor areas.

8. Insurance/Responsibility

8.1. The Organizer does not assume the obligation to exercise proper care of exhibits, objects (equipment, products, etc.) that are the property of the Exhibitor or the exhibitor's personnel present in the stand. The Exhibitor/Co-exhibitor is solely responsible for the condition of the objects (products, equipment, materials, etc.) both during the stand setup, the effective conduct of the event, and during the dismantling period.

8.2. The Exhibitor/Co-exhibitor will be solely responsible for the integrity of the goods transported throughout the handling and transport period; any deficiencies/damage will be remedied at their expense.

Any liability of the Organizer for material damages caused to the exhibitor/co-exhibitor during the stand setup, the effective conduct of the event, and during the dismantling period is excluded. However, the Organizer's liability for damages caused intentionally or as a result of gross negligence is not excluded.

8.3. The Exhibitor is solely responsible for any direct and/or indirect damages caused by their fault, the exhibitor's personnel, proxies, or third parties acting for or on behalf of the exhibitor.

8.4. The Organizer recommends insuring goods or personal insurance. This can be done through specialized companies, paying the required fees.

8.5. The Organizer is exempt from any liability in case of interruptions of electricity supply, for the provision of thermal energy, water, due to reasons attributable to the suppliers of these utilities.

9. Internal Authority

9.1. The Organizer has full authority regarding the exhibition center during events, from the beginning of the construction period until the end of the dismantling period. The Organizer reserves the right to issue instructions, refuse participation, or even evacuate the space if it deems this measure necessary and useful for the successful conduct of the activity. The Organizer reserves the right to take photographs and films related to stands and exhibits and to use them for the promotion of fairs and in the press.

10. Force Majeure

10.1. Force majeure, agreed to be that unforeseeable and insurmountable event occurring after the conclusion of the contract and preventing one or more parties from fulfilling the obligations assumed under the contract, exempts the party invoking it from liability under the law. The case of force majeure shall be communicated by the interested party within 2 (two) days from its occurrence and shall be confirmed by official documents authenticated by the Chamber of Commerce, Industry, Navigation, and Agriculture Constanta.

10.2. The evidentiary documents attesting to the existence of the force majeure event shall be presented to the other party within 5 (five) days from the date of their issuance by the Chamber of Commerce, Industry, Navigation, and Agriculture Constanta.

10.3. The termination of the force majeure event, confirmed by the Chamber of Commerce, Industry, Navigation, and Agriculture Constanta, shall be immediately communicated to the interested party.

10.4. The parties undertake to make every effort to limit the effects of force majeure in time. A fair may be canceled or the opening/closing date may be postponed in the event of force majeure. The Organizer will inform exhibitors within 5 (five) days from the occurrence of the force majeure event.

11. Termination of the Adhesion-Contract

The Adhesion-Contract terminates automatically without any other formality and without the intervention of other bodies, in the following cases:

- upon expiration of the agreed period, if the parties have not agreed to an extension;
- at the request of one of the parties who is unable to fulfill their obligations;
- by the agreement of the parties expressed in writing;
- in case of force majeure, occurring for a duration of more than one day, which prevents the performance of the contract, if the parties do not agree otherwise;
- if one of the parties fails to fulfill their obligations in full for more than 2 (two) days;
- unilaterally, at the request of one party with a notice period of 5 (five) days.

The Organizer reserves the right to terminate the Adhesion-Contract if it finds that the authorizations, approvals, information, and/or assurances provided by the Exhibitor are inaccurate, incomplete, and/or if the agreed circumstances have changed.

Termination of the adhesion contract does not extinguish the payment obligations due.

12. Amendment of the Contract

12.1. This adhesion contract may only be modified by an additional act signed by both parties.

13. Disputes

13.1. Any dispute arising out of or in connection with this contract, including regarding its conclusion, execution, or termination, shall be settled by the arbitration of the International Commercial Arbitration Court attached to the Chamber of Commerce, Industry, Navigation, and Agriculture Constanta, in accordance with the Rules of Arbitration Procedure of the International Commercial Arbitration Court, in force, published in the Official Gazette of Romania Part I.

14. Final Provisions

14.1. These Specific Participation Conditions are supplemented by the provisions of the General, Technical, and Participation Conditions of the Fairs and Exhibitions organized within the Exhibition Pavilion Constanta, with Directive 2008/8/EC of the Council of 12 February 2008, with the applicable amendments as of 01.07.2011 and Directive no. 2006/112/EC of 28.11.2006, concerning the common VAT system.

14.2. This Adhesion Contract, together with the General, Technical, and Participation Conditions, which are an integral part thereof, represents the will of the Parties and supersedes any verbal or written agreement between them prior to its conclusion. Both parties declare and warrant that they have full competence to sign this Contract and to fulfill the obligations arising therefrom. If any of the clauses above are found to be null or invalid, regardless of the cause, this shall not affect the validity of the other clauses.
